Slips, trips & falls	All users may suffer injury if they slip or fall etc, e.g. steps, on wet floors	Low	Low	<ul style="list-style-type: none"> <li>Floor mat provided at entrance to reduce water ingress</li> <li>Changing rooms have slip resistant surface</li> <li>Appropriate lighting throughout building.</li> <li>No storage on thoroughfares</li> <li>No trailing leads/cables</li> <li>First aid kit maintained in club house</li> </ul>	Low
Burns / scalds	All users may suffer burns or scalds from either hot water supply or appliances	Low	Low	<ul style="list-style-type: none"> <li>Hot water supply has thermostatic control valve</li> </ul>	Low
Fire	All users could suffer injury resulting from a fire	Medium	Low	<ul style="list-style-type: none"> <li>Fire exits marked</li> </ul>	Low
Hazardous substances	Anyone using chemicals for cleaning etc at risk from injury caused by e.g. contact with chemicals, inhalation of vapours.	Medium	Low	<ul style="list-style-type: none"> <li>Domestic type products only are used for cleaning etc</li> <li>Products stored out-of-site in locked cupboard</li> </ul>	Low

## Outside areas

Vehicles / traffic from car park	All users could suffer injury as a result of impact with moving vehicle in car park adjacent to club house.	Medium	Low	<ul style="list-style-type: none"> <li>Warning users over danger in car park</li> </ul>	Low
Terrace	All users may suffer injury if they slip or fall etc, e.g. steps, on wet floors.	Low	Low	<ul style="list-style-type: none"> <li>Ensure outside furniture is correctly positioned and not stacked up</li> <li>Area is kept clear of obstacles and swept daily</li> </ul>	Low
Containers	Containers are positioned in car park and danger can arise when participants are getting kitted up.	Medium	Low	<ul style="list-style-type: none"> <li>use coned off area for participants to put kit on away from moving cars</li> </ul>	Low
